Ecological Society is a well-known NGO working in the field of ecological restoration, to guide in creating a viable and sustainable model.

MKCL's objective in supporting this cause is to conduct a comprehensive and long term activity in developing a viable, sustainable and replicable model of restoration that can act as a model and can be replicated.

- I. To conserve the present biodiversity on the land;
- II. To employ techniques of ecological restoration to improve the biodiversity on the land using measures which are financially viable and sustainable;
- III. To create opportunities of livelihood for the villagers, during and after the process of restoration.

Gopalpur village is located in Pandharpur Taluka in Solapur District. Shri Vithal Education and Research Institute's College of Engineering (SVERI) is also located in Gopalpur. MKCL Knowledge Foundation have established a facility for manufacturing and training of various technologies developed by the Bhabha Atomic Research Center (BARC) and provided through its AKRUTI Tech Pack.

MKCL Knowledge Foundation develops and provides the following products by using the technology made available by BARC:

- Filtration of water: Water purifier models are prepared using BARC's Silver Nano filter Membrane
 Technology for Water Purification, MKCL Knowledge Foundation is partnering to promote wider
 access to clean water and solving the challenge of the water crisis.
- 2. Solar Dryers: Solar energy can be harnessed to help farmers preserve their produce. Due to incessant rains, farmers are facing problems in preserving and drying their harvest/ farm produce. Sometimes farmers sell at very low prices during the harvest season because they cannot store or preserve their surplus products. The Foldable Solar Dryer can offer relief to farmers and women's Self Help Groups (SHG's) by providing them an additional source of income. Benefits of Foldable Solar Dryer can be listed as:
 - 1. Drying is faster because inside the dryer it is warmer than outside.
 - 2. Less risk of spoilage because of the speed of drying
 - 3. The product is protected against flies, pests, rain, and dust.
 - 4. It is labor-saving. The product can be left in the dryer overnight or during rain.
 - 5. The quality of the product is better in terms of nutrients, hygiene, and color.

- 3. **Soil Testing for organic carbon detection:** Organic Carbon is a vital element in soil. It helps in retaining the water in the soil and also improving the yield. BARC has developed a technology that would help the farmers identifying the quantity of organic carbon in their farm before sowing.
