#### **CSR PROJECT I – NIRMAN**

## (A) CSR projects/Activities identified:

In recent times, it is observed that the youths desire to do something different and resolve challenging problems of society. In our country, there are challenges at the urban and rural levels. Also, there are enough challenges in the field of climate change, malnutrition, health, education, environment and many more. The youth need clear direction from social leaders and a platform through which they can address these challenges.

NIRMAN is a project initiated by eminent Social Scientists, Dr. Abhay Bang and Dr. Rani Bang founders of The Society for Education, Action and Research in Community Health ('SEARCH') which is designed as a youth initiative to identify, nurture and organize the young change-makers to solve various societal challenges. It is an educational process to train the youth to take up crucial issues and problems in society. NIRMAN provides guidance, expertise, a platform, and an environment to inculcate self-learning and encourages youth to take social action. NIRMAN encourages the youth to find a broader purpose in their lives beyond simply earning money, inspires them for social action and cultivates a vibrant and supportive community of such like-minded youth. NIRMAN aims to create a large group of young professionals having the desire and the capability to understand and solve burning social problems.

#### **Educational Goals:**

- 1. To sensitize the youth towards various societal challenges by way of education through exposure, experience, efforts, and experimentation.
- 2. To enable the youth to find out and actualize their mission and to equip them with the necessary skills, values and vision to increase the effectiveness of their work.
- 3. To give them an opportunity and atmosphere to grow by way of 'Self Learning' and to find a more meaningful and joyful purpose for their life while working on societal challenges.
- 4. To facilitate the interaction with eminent social leaders and change-makers.

# Methodology:

- 1. Conduct 3 physical training workshops for medico and non-medico participants for NIRMAN 14 batch.
- 2. Conduct 4 physical training workshops for medico and non-medico participants from NIRMAN 13 batch.
- 3. Conduct widespread outreach, publicity campaign and selection process for the upcoming NIRMAN 14 batch.
- 4. Conduct a selection process for the NIRMAN 14 batch involving scrutiny of written applications, personal interviews, and assignments, and recruit a cohort of 120 participants.
- 5. Conduct 2 physical training workshops for medico and non-medico participants from NIRMAN 14 batch.
- 6. As a part of the memorandum of understanding (MoU) between NIRMAN and Maharashtra University of Health Sciences (MUHS), it is planned to design and conduct short sensitization modules across medical and dental colleges in Maharashtra.
- 7. To analyze the new feedback received on *NIRMAN's Framework of Youth Flourishing* developed from the experience of working with thousands of youths over a decade and make necessary changes, if needed.
- 8. To continue the process of identifying and networking with various resource persons and host organizations to develop a set of possible work options that NIRMAN participants can take up after the training workshops.
- 9. Through "Kar Ke Dekho" Fellowship, providing financial and mentoring support to select Nirman Alumni (6) for contributing full-time in social action.
- 10. To continue the process of designing and deploying a strong media, communications and outreach strategy of NIRMAN. Publishing news, articles and short stories in various newspapers, online portals and college student magazines.
- 11. Designing approx. 80 new interesting, thought-provoking and meaningful posters and a collective repository of a total of 400 posters targeted at young people and spreading through social media.
- 12. Building a curated photo and video repository of selected good photos and videos from various NIRMAN batches and other events, from the existing data-base of over 300 GB data.

- 13. Organizing systematic follow-up and networking efforts with 1000 plus alumni throughout the year to facilitate their social action & educational journey and to strengthen the NIRMAN community.
- 14. Having regular team meetings to share the updates and do appropriate interventions as required. Continuously providing inputs related to the professional and personal growth of these alumni and encouraging them for social contributions.
- 15. To continue the activity of Ekalavya a remote telephonic intervention to provide developmental and social action inputs to a specific group of 'not selected for workshops' candidates.
- 16. Implementing an internship program with NIRMAN for students from various disciplines.
- 17. To continue the process of exploring possible associations regarding providing flourishing inputs and nurturing youth leadership with various institutes like IIM Ahmedabad, IIT Kharagpur, IIM Nagpur, Azim Premji University, Ashoka University, IIT Bombay, SRISHTI Shodhyatra, IRMA-NID, St. Johns Medical College Bangalore, ATREE Bangalore, etc.
- 18. To continue the process of curating and publishing insightful articles in newspapers like 'Loksatta', regarding youth flourishing, purpose development, social sector, social issues, and findings from analyses of NIRMAN datasets & program experience.
- 19. Developing and/or updating useful frameworks from the empirical experience in NIRMAN and the corresponding body of knowledge.
- 20. Performance monitoring and capacity building of the members in the NIRMAN team.

#### CSR PROJECT III – ECO-RESTORATION PROGRAM (DARA-CHINCHORA)

## (A) CSR projects/Activities identified:

Ecological restoration is one of the most appreciated and time-tested phenomena for repairing the damaged earth and development, ensuring environmental sustainability, maintaining ecological balance, restoring local flora and fauna, and creating sustainable livelihoods.

Dara and Chinchora are two adjacent villages in the Satpuda region in the Nandurbar district. These villages have secured 137 hectares of land from the forest department under The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.

The villagers and the gram panchayat have understood the importance of this activity and have continued their faith in the process of implementation of the ecological restoration measures to further improve the quality of land secured under Community Forest Rights. The Gram Panchayat resolved this because it has seen the results of the efforts taken by the team and felt that this has contributed to enhancing the standard of living of the villagers.

Ecological Society is a renowned NGO working in the field of ecological restoration that would continue offering its guidance in creating a viable and sustainable model. Ecological Society's course on Sustainable Development is a popular course among architects and environmental enthusiast.

MKCL's objective in supporting this cause is to conduct a comprehensive and long-term activity in developing a viable, sustainable, and replicable model of restoration that can be replicated for the following objectives:

- 1. To conserve the biodiversity created and developed on the land.
- 2. To employ new techniques for the consolidation of ecological restoration on the land and explore new measures for making this activity financially viable and sustainable.
- 3. To create opportunities for livelihood for the villagers, during and after the process of restoration.
- 4. To nurture medical plants further and promote them for enhancing the quality of life of the locals.
- 5. To consult with the local Vaidu Community to plant new medicinal plants.

## Methodology:

- 1. To ensure enough grass and low-density timber is made available as fodder for the cattle and fuel in the villages.
- 2. To ensure that a good quality of soil is developed because of protection from encroachment, which can help for the germination of seeds.
- 3. To ensure the protection of medicinal plants by constructing low-cost but steady compounds and in the long run, derive economic returns which would help in ensuring the sustainability of this project.

Education is for the purpose of fostering knowledge. How can we impart and receive education in today's age? How should lifelong learning be approached? How to enhance the capacity to embrace upcoming challenges and foster true education? These are some challenging questions.

In recent years, the impact of challenges that are reshaping the daily context of human life has been increasingly evident worldwide. Due to this, there is a pressing need to fundamentally restructure school and university education, recognizing the urgent need for transformative changes in education.

Historically, green and industrial revolutions, etc., have brought about changes in human life through which the world has changed. However, it took centuries for the results of these revolutions to be visible. The industrial revolution took a century to cover the world and "industrial civilization" was created on earth. The information technology revolution took half a century to establish a digital empire in the world. Today's changing revolutions are happening at lightning speed.

Rapid specialization and dynamic adjustment to changing circumstances are the key factors of today's education. MKCL, in association with Yashwantrao Chavan Center Mumbai, has initiated a scholarship for innovative teachers in the State of Maharashtra who would try to find solutions to these challenges using the school and their students.

Yashwantrao Chavan Center has vision of Creating equal opportunities for all individuals for a progressive and prosperous society. It is a non-partisan and secular platform that aims to address the various pressing issues faced by Maharashtra by creating a dialogue around it. It has two representatives of Government of Maharashtra on its Board of Trustees. During the last more than three decades, the Centre has tried to take forward the vision of Late Yashwantrao Chavan.

#### **Educational Goals:**

The following are the Educational Goals of this project:

- 1. Nurturing knowledge, creativity, aesthetic vision, love, and compassion in students' personalities.
- 2. Creating a foundation for "lifelong learning" in students, fostering a culture of "learn-unlearn-relearn".
- 3. Developing the ability to ask questions, curiosity, critical thinking, scientific perspective, presenting ideas, independent thinking, independent expression, courage to learn from failures, adventurous and exploratory attitude, preparedness to accept risks, and fostering such qualities.
- 4. Developing soft skills, communication skills, teamwork abilities, qualities of scouting and guiding impartial and dedicated service attitude and fostering such qualities.
- 5. Promoting entrepreneurial skills among students, derived from the experiences of school life.
- 6. Teaching students about creative knowledge construction while making them aware of how that construction can be knowledge-based, socially impactful, environmentally friendly, and technologically inclined.
- 7. Ensuring that students become successful partners with artificial intelligence and technology rather than becoming their slaves.
- 8. Making efforts to achieve the holistic development of students' personalities by instilling the rich and integral human capabilities acquired from progress and culture. Students should not become dry, mechanical, or robot-like, and it is essential to take care of this aspect. (If not done so, they will not only be useless but also become a burden.) Inspiring and striving to make students sensitive, creative, rational, and well-cultured individuals (Teach children to be more cultured, teach machines to become smarter machines, and save children from becoming slaves to machines!).
- 9. Developing capable personalities among students who can confidently face the challenges and opportunities in the world of progress and globalization.
- 10. Promoting a way of life that includes fearlessness, humility, truth, non-violence, simple living, satisfaction in work, self-control over desires and minds, using natural resources in a sustainable manner, and fulfilling local needs as much as possible. Developing an educational environment that nurtures such a lifestyle.
- 11. Instilling respect and acceptance of the values enshrined in the Indian Constitution, fulfilling our duties and rights with sincerity, and developing a sense of reverence for the diverse Indian culture that has evolved and maintaining sensitivity towards various cultures around the world, thereby fostering wise citizenship among children.

- 2. The scholarship period is for one academic year of FY 2023-24.
- 3. Teachers teaching in school and junior college would qualify for applying for this scholarship.
- 4. A total of 20 teachers would be identified through a process of scrutiny of their proposals.

#### **CSR PROJECT IX - NYAY SWARAJYA**

## (A) CSR projects/Activities identified:

Swarajya means 'Self-governance'. Mahatma Gandhi's explanation of Swarajya is not only a guide in the field of justice, but also an inspiration. Through self-control and dialogue, if we can achieve justice through such non-violent means, then we can attain "Nyay Swarajya".

To facilitate this dialogue, the presence of a mediator who is a legal expert has been accepted by the Supreme Court of India. By accepting this, we can take "Nyay Swarajya" to the level of legal legitimacy and make it sustainable. In many progressive countries, this practice has become popular and mainstream consequently reducing the burden on the courts and the time required for Dispute Resolution.

The process of Alternative Dispute Resolution (ADR), which involves formally and informally discussing issues and finding solutions without resorting to the rigidity and technicality of the legal process, aligns with social justice resolutions. This can help root out the inhumane and extra-legal practices that pervade certain societies. Therefore, before cases go to court, it can be an extremely important way to build a new and just society through the implementation of new evolved legal practices.

To institutionalize this process in our country, it is necessary for organizations to take the lead.

#### **Educational Goals:**

The following are the Educational Goals of this project:

- 1. To propagate the importance of the Alternative Dispute Resolution method among young lawyers.
- 2. To encourage people to settle disputes outside the court and resolve arguments to eliminate conflict.
- 3. To provide guidance to young advocates in handling disputes through mediation with the help of senior and experienced lawyers.
- 4. To provide guidance to lawyers for explaining the legal terms in user-friendly terms. This would help in the faster settlement of disputes.

# Methodology:

- 1. To initiate mediation services in Pune.
- 2. To appoint one experienced lawyer as subject matter expert for providing guidance and training in the field of mediation and ADR.

- 3. To appoint graduated legal practitioners keen in obtaining experience in mediation and ADR services and to provide them with requisite training under the guidance of experienced lawyers.

#### CSR PROJECT X: NIPUN BHARAT PROGAM IN ASSOCIATION WITH GRAMMANGAL

# (A) CSR projects/Activities identified:

As per The National Education Policy 2020, the highest priority of the education system will be to achieve Universal Foundational Literacy and Numeracy (FLN) in primary schools by 2025. The rest of this Policy will become relevant for our students only if this most basic learning requirement (i.e. reading, writing, and arithmetic at the foundational level) is first achieved. To this end, a National Mission on Foundational Literacy and Numeracy will be set up by the Ministry of Education as a priority. Accordingly, all State/UT governments will immediately prepare an implementation plan for attaining universal foundational literacy and numeracy in all primary schools, identifying stage-wise targets and goals to be achieved by 2025, and closely tracking and monitoring the progress of the same.

The following are the beneficiaries of the scheme.

- 1. This scheme emphasizes children in the age bracket of 3 to 9 years.
- 2. It also supports students in preschools upto class 3.
- 3. Children without a foundational skill and studying in classes 4 and 5 will be offered peer support, tutor guidance and additional learning materials to strengthen their educational proficiency.
- 4. National Initiative for Proficiency in Reading with Understanding and Numeracy (NIPUN) aims to complete its set objectives by private and Government aided schools by FY 2026-27. This will help achieve universal attainment of FLN skills.

## **Educational Goals:**

The following are the Educational Goals of this project:

- 1. Improved foundational skills of children to reduce dropouts.
- 2. Increase the number of students clearing the primary, upper primary and secondary stages.
- 3. It envisions an enhanced education quality due to conducive and activity-based teaching.
- 4. Practice of toy-based and unique pedagogies or experimental teaching to make the sessions fun and interesting.

- 5. Forming a training module that focuses on developing motor and physical skills, emotional and social skills, cognitive., numeracy, literacy, life skills and more.
- 6. Ensure holistic development of every child, which will be tracked down in reports.
- 7. Encourage children to achieve steep learning for future needs like employment and life decisions.
- 8. Create creative assessments such as quizzes, games, polls, etc.

## Methodology:

Grammangal was started in 1982 by renowned educationists Ms. Anutai Wagh and Mr. Ramesh Panse to provide holistic education to the rural and tribal children of Palghar District. Grammangal has developed and implemented teaching-learning methodologies that are strongly grounded in the principles and current understanding of Cognitive Science, Child Development and Learning.
